and business brokerage professionals can meet and network. This is the place where professionals can get together once a month, learn some new techniques and close more deals. MAREMA is where deals are made.

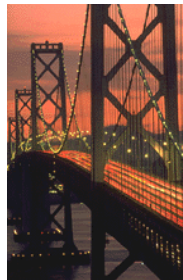
